**HOW TO BOOK THIS EVENT**

The following information will help you book your Alaska Cruise and Twilight Convention at Sea properly and with minimal effort. Please read all the information carefully before completing the reservation form. Approximately 2 to 4 weeks prior to sailing, your cruise documents, T-shirts and Twilight Cruise Events Schedule will be sent to you.

**TYPES OF CABINS:** Cabin prices vary by the category and type of accommodations you select. There are Inside cabins, without a window; Obstructed View cabins (with a window but a lifeboat is outside and obstructs the view); Ocean View cabins (with a window and a view); Superior Verandah Suites (mini suites) with private verandah; Deluxe Verandah Suites with private verandah. **(I) TWO PERSONS SHARING SAME CABIN:** Double occupancy means two passengers share one cabin.

**(II) TRIPLE and QUAD OCCUPANCY:** The first two passengers pay the double occupancy rate then the 3<sup>rd</sup> and/or 4<sup>th</sup> passenger(s) pay(s) the 3<sup>rd</sup>/4<sup>th</sup> rate.

**(III) SINGLE OCCUPANCY:** This is for those of you who plan to solely occupy a cabin. Pricing is 150% to 200% of the per person double occupancy fare.

**(IV) PHYSICALLY CHALLENGED (PC):** There are a limited number of specially equipped cabins for the physically challenged.

**PAYMENT INFORMATION:** A \$200.00 per person deposit is due at the time of booking, payable by check or credit card. Final payment is due on or before May 20, 2010 and may be paid by check or credit card.

**TWILIGHT CONVENTION AT SEA REGISTRATION FEE:** A \$150 registration fee will be added to your invoice and is due at any time prior to final payment. This may be paid by check payable to Cruises Cruises or by American Express, Visa, MC or Discover. Please fill out the Registration Form and send it along with your payment.

**PRE REGISTRATION FOR YOUR CRUISE:** To facilitate check-in at the pier, please go to [www.hollandamerica.com](http://www.hollandamerica.com) and click on the On Line Check-in to pre-register for your cruise. You will need your booking number to do this. After completing the form, please download and print a copy and bring it with you to the pier.

**PASSPORTS REQUIRED:** Each passenger must bring proper proof of citizenship. For U.S. Citizens a valid passport is recommended but at the moment they government will accept an original or certified copy of your birth certificate along with a photo I.D. For non U.S. citizens, a valid passport is required and you will have to check with the consulate to see if any visas are required. Anyone without proper proof of citizenship will be denied boarding.

**AIRFARE AND TRANSFERS** Please call us for a quote for airfare and transfers. It is recommended that you arrive no later than 1:00pm on the day of embarkation August 8<sup>th</sup> and that you schedule a return flight no earlier than 12:30pm on the day of disembarkation August 15<sup>th</sup>.

**GRATUITIES:** Holland America will charge approximately \$10 per person per day to your onboard account for gratuities for your cabin steward and dining room stewards.

**AGE REQUIREMENTS:** If you are under 21 years of age the cruise line requires that you travel with someone 21 years or older in the same cabin or in a cabin nearby. Certain exceptions may be made at the discretion of the cruise line.

**CANCELLATIONS AND REFUNDS:** If a cancellation occurs, the following charges will be assessed:

***Cancellation Penalties begin on May 20, 2010.*** All cancellations must be received in writing. Name changes will be allowed at Holland America's discretion and are subject to change fees and rate increases. Cruises Cruises Cruises reserves the right to cancel this event due to lack of participation in which case you will receive a full refund. Trip Cancellation and Interruption insurance is available and recommended.
